

COOKIES POLICY

As required by Article 129 of the Law of 13 June 2005 on Electronic Communications (hereafter "LEC"), Our company wishes to inform its website users about the company's use of cookies.

A cookie is a file containing an identifier that is sent by a web server to your web browser and is stored on your computer (or other web-enabled device such as a smartphone or tablet). The identifier is then sent back to the server each time your browser requests a page from the server.

Cookies are used solely for the purpose of identifying users returning to a website. Our company does not use cookies for direct marketing or promotional purposes.

How to control and delete cookies

Most web browsers accept cookies by default, but you can change your settings to block cookies or to prompt you every time a web server attempts to create a cookie on your device.

All modern browsers allow you to restrict or block cookies. These settings will typically be found in the options or preferences menu of your specific browser. In order to understand these settings, the following links may be helpful:

Complete list of cookies used that could be used on this site

1. CWSLanguage

- **Purpose:** to remember the user's language preference
- **Legal status:** As a user interface customisation cookie, this cookie is exempt from the informed user consent requirement pursuant to Article 129 of the LEC. See point 3.6 of opinion 04/2012 of the Article 29 Working Group on exceptions to the cookie consent requirement.

2. ACOOKIE

- **Purpose:** to estimate the number of unique website visitors
- **Legal status:** as a third party analytics cookie, i.e. sent by a third party to build up a browsing history of unique website visitors, this cookie is not exempt from the informed user consent requirement (cf. pop-up windows).

3. WT_FPC

- **Purpose:** to balance load demand between available servers
- **Legal status:** as a session cookie, this cookie is exempt from the informed user consent requirement pursuant to Article 129 of the LEC. See point 3.6 of opinion 04/2012 of the Article 29 Working Group on exceptions to the cookie consent requirement.

4. BIGipServer~Legacy~aginsurancexp_pool

- **Purpose:** to balance load demand between available servers
- **Legal status:** as a session cookie, this cookie is exempt from the informed user consent requirement pursuant to Article 129 of the LEC. See point 3.6 of opinion 04/2012 of the Article 29 Working Group on exceptions to the cookie consent requirement.

5. ASP Session

- **Purpose:** to store a session ID for each user until the end of the session
- **Legal status:** as a session cookie, this cookie is exempt from the informed user consent requirement pursuant to Article 129 of the LEC. See point 3.6 of opinion 04/2012 of the Article 29 Working Group on exceptions to the cookie consent requirement

- **Purpose:** to remember your preferences, personal details, connections and professional interests in order to improve the user experience in your current browsing session or on future visits to the site, to allow you to share comments, notes, pages and tags, and to facilitate access to social networks and online social tools.
